Re: Letter Agreement Between North Bend and Fire District No. 10

Dear Chief Soptich:

Thank you for your work on the Joint Operation Interlocal between the City of North Bend and Fire District No. 10. This letter agreement memorializes, as extrinsic evidence, the intent of the City and the Fire District regarding the interpretation of paragraph 8.2 of the Interlocal. Paragraph 8.2, in pertinent part, states as follows:

North Bend, and Issaquah for the years after 1999, shall also contribute annually to the Board all emergency medical service taxes and all other City fire department revenue, including but not limited to, contract income, state taxes and other revenue, and all fire and emergency services related fees, mitigation and charges for building and land development.

The City and Fire District intend that this contract term be interpreted so that any revenue North Bend contributes to the Board which is from fire and emergency services related fees, mitigation and charges for building and land development shall be spent by the Board on facilities, equipment, or construction in the City of North Bend, if specifically collected for this purpose. If nonspecific fees are collected, however, the Board is authorized to use these fees for facilities, equipment, or construction anywhere within the consolidated district's jurisdiction.

The City and Fire District further intend that the above language includes but is not limited to, impact fees authorized pursuant to RCW 82.02 and SEPA mitigation fees.

The City and the Fire District also intend that the Board or its designee have an opportunity to consider and comment on a proposed fire impact fee ordinance, if and when the City begins the process to draft said ordinance, and proposed SEPA mitigation fees for fire and emergency services
