RE: Jail Daily Bed Rate and Medical Per Diem 2012

Dear Craig and Dennis,

In accordance with our current Jail Use Agreements the following calculations have resulted in the establishment of the 2012 rates.

For 2012, the daily bed rate is \$71.97 per day, and the medical per diem is \$3.90 per day. The combined cost is \$75.87 per day, which represents a \$3.10 overall increase or 4.26%. This change will be implemented on Jan. 01, 2012.

The language in the agreements calls for recalculations annually, and provides the formula utilized.

Below are the July 31, 2010 through Jun 30, 2011 Jail Costs divided by the total person days. Medical consists of all medical expenditures for the designated period, minus the Correctional Healthcare Companies contract costs, which are included in the total expenditures of the jail. This figure divided by total person days served sets the Medical Per Diem rate.
