The fee for review and inspection of public improvements (such as curb, gutter and sidewalk, utility main extensions, etc) and on-site storm drainage systems is 10% of the value of those improvements and systems. The value is determined by using the Public Works Improvement Evaluation Form, in [Excel](#) or [PDF](#).

- (1) Multiple patches that are within the vicinity of each other will be measured collectively to determine the fee.
- (2) When a patch is associated with street widening to new curb, the patch will be calculated to a max width of 2 ft.
- (3) Any permit applicant that is required to overlay the street as a condition of their project will not pay the Street Cut Fee for any street cuts in the overlay area.
