The term of the open Commission position will commence once a candidate is appointed per RCW 53.12.070 and will expire effective November 26, 2013, following certification of the November 5, 2013 General Election.

Residents interested in applying for the Commissioner vacancy must reside in the Port of Indianola, District 3 (as noted on map).

Applications are due at 12:00 PM (noon) on Wednesday, September 25, 2013. Application received after 12:00 PM on September 25, 2013 will not be accepted.

The Board is responsible for setting policy, adopting the annual budget, adopting resolutions, determining the services the Port provides and funding levels for those services, and appointing citizens to its advisory boards.

- If appointed you will be required by state law to file financial disclosure statements with the Washington Public Disclosure Commission (www.pdc.wa.gov).
- Attendance is required at regular Commissioner Meetings, which are held on first Tuesday of each month, starting at 7:00 PM. From time to time, the President may call special Port meetings. Attendance is required at special meetings.

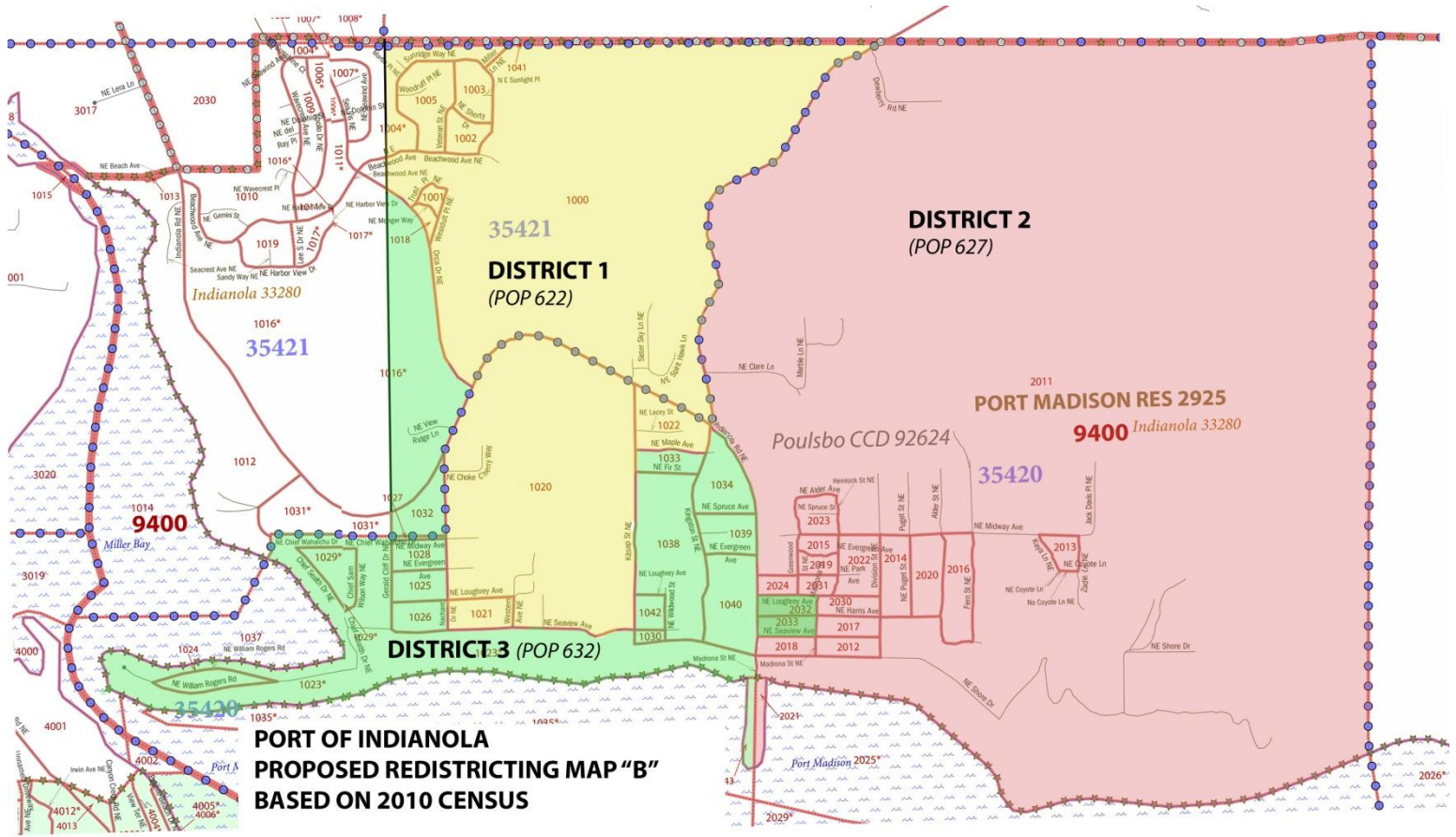
