

ORDINANCE No. 537-2018
AN ORDINANCE OF THE CITY OF ELECTRIC CITY, WASHINGTON, ADOPTING
THE BUDGET FOR THE CITY FOR THE FISCAL YEAR ENDING DECEMBER 31,
2019

WHEREAS, The Mayor of the City of Electric City, Washington, completed and placed on file with the Clerk/Treasurer a proposed budget for the year 2019, and has given notice of the time and place of hearings thereon according to law and met in accordance with said notices and considered the proposed budget and there being no objections thereto, and

WHEREAS, The said budget does not exceed the lawful limit of taxation allowed by law to be levied on the property within the City of Electric City for the purposes set forth in said budget, and the estimated expenditures set forth in said budget being all necessary to carry on the government of said City for said year and being sufficient to meet the various needs of said City during said period,

NOW THEREFORE, Be it ordained by the Council of the City of Electric City, Washington, as follows:

Section I: In accordance with the laws of the state of Washington, RCW 35.33.075, the final budget for the year 2019 for the City of Electric City, Washington, is hereby adopted by reference. The following is a summary of the totals of estimated resources and appropriations for each separate fund and an aggregate total for all such funds combined.

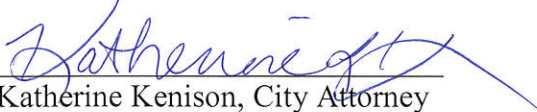
