AGENDA SUBJECT: Purchase Order for Nedland NC-200 Compactor and associated <u>Resolution to Waive Competitive Bidding</u>
BACKGROUND/SUMMARY: WORK SESSION DATE: (if applicable) <u>May 20, 2015</u> In 2000 several stationary compactors were considered in a competitive bidding process. A Nedland unit was selected based on best configuration according to specifications and low bid. Several Nedland units have since been purchased. Given the excellent performance history of these units, with an objective of interchangeable maintenance, parts/repair characteristics, a single service provider, and to avoid dissimilar equipment types with no local performance record, Public Works is recommending the purchase of this unit without competitive bidding. STATION INCLUDING ALL SETUP AND TRAINING)
WITHOUT COMPETITIVE BIDDING)

WHEREAS, Recycle Systems, LLC supplied and installed the 4 existing Nedland NC-200 Stationary Compactors with 30 cubic yard boxes at the Bayview Transfer Station in 2000 and 2003, following competitive bidding, and in 2005 and 2010 as a special facilities purchase; and

WHEREAS, funds are available in the solid waste budget for installation of a new compactor to replace the oldest compactor that has reached the end of its life cycle; and

WHEREAS, compatibility with existing equipment including operation, wiring, electronics, servicing, spare parts and training are primary objectives of efficient equipment installation and maintenance and hence this purchase involves special facilities; and

WHEREAS, Recycle Systems, Inc. is the only firm that can effectively supply, install, and provide services compatible with existing compactors pursuant to RCW 39.04.280(1)(a); and

WHEREAS, ICC 2.30A.010 (A)(9) and RCW 39.04.280(1)(b) permit a waiver from competitive bidding for public works purchases involving special facilities;
NOW, THEREFORE,

BE IT HEREBY RESOLVED that competitive bidding is waived, pursuant to ICC 2.30A.010 (A)(9) and RCW 39.04.280(1)(a) and (b), and the Chairman of the Board of Commissioners, acting on behalf of the Board of County Commissioners, is authorized to sign a Purchase Order with Recycle Systems, LLC to provide a Nedland NC-200 stationary compactor with a 30 Cubic Yard tapered octagonal container including transportation, installation and training at the Bayview Transfer Station and relocation and installation of the older Nedland compactor at the Bayview Transfer Station to Oak Harbor at a lump-sum cost of \$26,519.54 including tax.
