

**ORDINANCE NO. 635**

AN ORDINANCE ADOPTING THE FINAL BUDGET FOR THE TOWN OF IONE, WASHINGTON FOR THE FISCAL YEAR 2022; PROVIDING FOR THE ADOPTION OF SAME BY REFERENCE BY THE ATTACHMENT THEREOF TO THIS ORDINANCE; PROVIDING FOR THE TRANSMITTAL OF COPIES OF SAME TO ASSOCIATION OF WASHINGTON CITIES AND WASHINGTON STATE AUDITOR.

BE IT ORDAINED BY THE COUNCIL OF THE TOWN OF IONE, WASHINGTON AS FOLLOWS:

SECTION I: A hearing having been held for the preliminary budget proposed for the Town of Ione, Washington for the fiscal year 2022; and amendments having been made, the council now, by this ordinance adopts by reference, the budget in its form and content as the same, attached hereto and is by reference made a part thereof,

SECTION II: In accordance with RCW 35.33.075, the total appropriations for each separate fund and the aggregate for all such funds are hereby declared to be as delineated in this instrument which is adopted by reference.

SECTION III: The Clerk-Treasurer is hereby directed to deposit property tax revenue to Current Expense fund-60%, Street fund-40% and fuel tax revenue to Street fund-20% and Arterial Street fund-80% throughout the year as it is receipted. The Clerk-Treasurer is directed to transmit a copy of the Ordinance, upon its adoption, complete with the attached budget to Association of Washington Cities and Washington State Auditor.

SECTION IV: This ordinance shall be in full force and effect beginning January 1, 2022.
