**A RESOLUTION OF THE CITY OF DUPONT  
ESTABLISHING A YOUTH COUNCIL**

**WHEREAS**, it is important and beneficial to all citizens of the City of DuPont to foster involvement of the community's youth in the process of government and the ideals of public service; and

**WHEREAS**, the City of DuPont recognizes the youth of our community as a significant community resource; and

**WHEREAS**, the creation of a Youth Council is an appropriate means to foster that involvement and increase the opportunities for young people to contribute to local government; and

**WHEREAS**, the City desires to receive continuous advice from the youth of the community on matters of interest to youth;

**NOW, THEREFORE THE CITY COUNCIL OF THE CITY OF DUPONT DOES RESOLVE AS FOLLOWS:**

Section 1. - Establishment. The DuPont Youth Council is hereby established and shall be referred to as "Youth Council". The Park Agency will be the governing agency that will assist and coordinate with the Youth Council.

Section 2. - Purpose. The purpose of the Youth Council shall be to involve youth in local government through participation on local boards and committees, increase volunteerism among youth in civic affairs, increase communication with youth in our community, and involve youth in planning youth activities for the community.

The Youth Council will serve as an advisory body to the City on matters dealing with the youth in our community.

Section 3. - Membership. The Youth Council shall consist of no more than twenty (20) voting members of high school age who attend school in the Steilacoom Historical School District or reside in the City of DuPont. Youth may serve on the Youth Council until they graduate from high school. The members of the Youth Council shall serve in such capacity without compensation.

Section 4. – Organization and Rules. The Youth Council shall adopt such rules for governing its procedures (hereafter referred to as “rules”), as it deems necessary or advisable, and shall keep a record of its proceedings, which record shall be a public record.


The Youth Council shall meet on a date and at a time set forth in its rules. All meetings shall be conducted consistent with the guidelines established within the Youth Council rules. A quorum shall consist of a simple majority of its members.

Section 5. – Effective Date. This resolution shall be in full force and effect upon passage and signatures hereon.
