

SHUT-OFF PENALTY AND COLLECTION CHARGES

Late Penalty – 10% of the amount of the delinquent bill.

Exceptions: For residential accounts for which there have been no penalty charges removed within the preceding two years, upon customer request, the penalty charge will be waived. For commercial accounts for which there have been no penalty charges removed within the preceding two years, upon customer request, the penalty charge will be reduced to 5%.

Interest on sewer charge liens - 8% per annum from the date of certification.

Sewer lien recording charge – Two times the fee charged by King County for lien recording, plus \$16.00.

'Party in interest' title report - \$40.00.

Water service termination notice mailing charge - \$10.00.

Water collection enforcement fee - \$30.00, applicable at 4:00 p.m. on the date scheduled for water service termination. An additional \$60.00 collection enforcement charge shall be paid to re-establish service between 4:15 p.m. and 8:00 a.m. on all weekdays, and at any time on Saturdays, Sundays and all holidays.

PERMIT FEE FOR PRE-TREATMENT – (to be set on a per-application basis)

EQUIPMENT RENTAL AND LABOR CHARGES

Equipment Rental and Labor Charges shall be in accordance with the Schedule of Charges attached hereto as Exhibit A.

NSF/DECLINED CREDIT/ATM CHARGES

\$35.00 for NSF and declined credit and ATM charges; \$35.00 for declined credit card and ATM card charges for payments made through the District's Web site.
