

RESOLUTION 3075

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF ANACORTES, WASHINGTON, authorizing the purchase of two Curotto cans from SWS Equipment, LLC. for use on the City's solid waste trucks, and waiving the competitive bidding requirement due to a sole source purchase and special market conditions, pursuant to RCW 39.04.280.

WHEREAS, RCW 39.04.280 provides that the City, by resolution, may waive competitive bidding requirements when a purchase is clearly and legitimately limited to a single source of supply, or when the purchase involves special facilities or market conditions.

WHEREAS, when the City converted to automated solid waste trucks back in 2015 the City bought 2 new trucks with Curotto cans (the attachment that goes on the front forks to pick up and dump cans); and

WHEREAS, staff originally thought that the Curotto cans would outlast the truck due to easily and continually repairing/rebuilding them. However, when the City recently replaced these 2 trucks on their normal 7 year replacement cycle it became evident that the Curotto cans should be on the same replacement cycle; and

WHEREAS, staff investigated doing a full rebuild of our existing units and found it to be cost prohibitive. A full in-house rebuild would cost the City an estimated \$30,000-\$40,000 each in parts alone and require a vast amount of internal labor to perform; and

WHEREAS, brand new Curotto cans cost approximately \$43,000 each plus shipping and tax, and have a 4-5 month lead-time; and

WHEREAS, SWS Equipment, LLC. currently has 2 Curotto cans in stock that were traded in. These units have never been used but they now must be sold as used. The price would be \$33,000 each plus shipping and tax; and

WHEREAS, SWS Equipment, LLC. indicated that this deal was only available for a short period of time and would be sold to the first purchaser; and

WHEREAS, the Public Works Operations Manager believes the price for these two "used" Curotto cans is a highly favorable price and would be sold to another party before the City has the time to comply with formal bidding requirements;

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Anacortes, Washington, as follows:

Section 1. The City Council of the City of Anacortes, Washington, finds that the purchase of these two "used" Curotto cans clearly limits the City of Anacortes to a single source of supply and special market conditions, justifying the waiver of competitive bidding requirements.

Section 2. The City Council of the City of Anacortes, Washington, hereby waives the bidding requirements for the purchase of the two “used” Curotto cans for use on the City’s solid waste trucks and authorizes sole source purchasing from SWS Equipment, LLC.

Section 3. Any actions of the City or its officers prior to the date hereof and consistent with the terms of this Resolution are ratified and confirmed.

Section 4. This Resolution shall be in full force and effect after its adoption and approval.

The foregoing resolution was ADOPTED by the City Council of the City of Anacortes, Washington, at a regular, open public meeting thereof this 7th day of March, 2022.





CONSUMER DISCLOSURE

From time to time, Ingram Micro OBO Cities Digital Inc OBO City of Anacortes (we, us or Company) may be required by law to provide to you certain written notices or disclosures. Getting paper copies
