## INTERLOCAL COOPERATION PURCHASING AGREEMENT

This Agreement is made this day by and between Douglas County, Washington, and East Wenatchee, Washington, each being a public agency as defined in RCW 39.34.020.

WHEREAS, the parties from time to time purchase goods and services pursuant to competitive bidding and wish to provide for cooperative purchasing.

NOW, THEREFORE, the parties do hereby agree as follows:

1. Pursuant to RCW 39.34.030(5), each party hereby extends to the other the right to cooperatively purchase goods and services under contracts awarded through competitive bidding process.
2. Each notice issued by a party requesting competitive bids for goods or services shall inform bidders that other public agencies shall have the right to cooperatively purchase the goods and/or services upon the same accepted price, terms and conditions, exclusive of freight and transportation fees: provided, that each party may omit the right of cooperative purchasing when doing so may favorably affect the bid prices received.
3. The party soliciting competitive bids shall comply with its own statutory and internal purchasing requirements and, in addition, shall post the solicitation notice as required by RCW 39.34.030(5).
