

**CITY OF WOODLAND, WASHINGTON**

**Ordinance No. 1325**

**AN ORDINANCE AMENDING WOODLAND MUNICIPAL CODE 5.04.090 AND PERMITTING THE ISSUANCE OF CITY BUSINESS LICENSES FOR CERTAIN BUSINESSES AUTHORIZED UNDER WASHINGTON INITIATIVE 502 AND AUTHORIZING A PUBLICATION BY SUMMARY**

The City of Woodland adopted zoning and development regulations which permit the operation of a business activity authorized under Washington State law and pursuant to Initiative 502.

WMC 5.04.090 as presently enacted is inconsistent with those regulations. Application of the ordinance in its current form would result in the denial of a business license for a business activity allowed under Washington State law and for a business activity taking place at a location permitted under Woodland zoning and development regulations.

The purpose of this ordinance is to amend WMC 5.04.090 to make the business license ordinance consistent with Washington State law and with Woodland zoning and development regulations.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF WOODLAND, WASHINGTON do ordain as follows:

**1. Current Ordinance - WMC 5.04.090.**

A business license will not be issued for any activity that is known to violate local and/or state and/or federal law. Issuance of a business license shall not relieve the applicant from the need to comply with all other applicable city ordinances.

**2. Amended Ordinance.**

Current WMC 5.04.090 is amended as follows:

A business license will not be issued for any activity that violates local and/or state and/or federal law, provided however, that this prohibition shall not apply to a business authorized under Washington law pursuant to Washington State Initiative 502, and further provided that the applicant holds a valid license issued by the Washington State Liquor Control Board pursuant to said Initiative. Issuance of a business license shall not relieve the applicant from the need to comply with all other applicable city ordinances.

**3. Severability.**

If any one or more sections, subsections, or sentences of this Ordinance are held to be unconstitutional or invalid, such decision shall not affect the validity of the remaining portion of this Ordinance and the same shall remain in full force and effect.

**4. Effective Date.**

This Ordinance shall take effect five days after its publication in the City's newspaper of record.






**SUMMARY OF ORDINANCE NO. 1325
