DESCRIPTION:

Under the policy direction of the City Manager, administers and presides over the Olympia Municipal Court.

ESSENTIAL FUNCTIONS:

Examples of Duties:

- 1. Supervises the staff and operations of the Municipal Court.
- 2. Ensures procedures and operations of the court comply with the State Administrator of the Courts' Office requirements.
- 3. Presides as the Municipal Court Judge.
- 4. Hears cases and renders judgments, establishing appropriate sentences and fines as necessary.
- 5. Punctual, regular and reliable attendance is essential for successful job performance.

Knowledge/Skills/Abilities:

- Knowledge of the standards for Municipal Court Administration in the State of Washington.
- 2. Knowledge of proper courtroom procedure and the rules of evidence.
- 3. Knowledge of criminal law.
- 4. Knowledge of local ordinances, laws and procedures.
- Ability to grasp complex factual data, draw appropriate conclusions and formulate sound legal decisions.
- 6. Ability to communicate complex legal ideas and/or decisions to a variety of audiences in clear, comprehensive and professional manner.
- 7. Ability to plan, organize and evaluate the work of others.
- 8. Ability to be sensitive to diverse personalities, lifestyles and orientations.
- 9. Ability to maintain an atmosphere of decorum and professionalism in the courtroom.
- 10. Ability to apply a broad legal background to judgments made of the bench.
- 11. Demonstrated punctual, regular and reliable attendance is required.

Experience/Education:

- 1. Graduation from a law school accredited by the American Bar Association required.
- 2. Broad legal background with emphasis on criminal law required.

Special Requirements:

- 1. Must possess a valid license to practice law in the State of Washington.
- 2. Valid Washington State Driver's License may be required.

Contacts:

- 1. The Municipal Court Judge is a public figure who is in contact with the court staff, attorneys, defendants, witnesses, complainants and law enforcement officers.
- 2. Courtroom encounters are by nature controversial and the Municipal Court Judge must possess a sensitivity to the diversity in personality, lifestyle and orientation of those with whom he/she comes into contact.

Supervision:

1. The Municipal Court Judge supervises the staff of the Municipal Court.

Accountability:

- 1. The Municipal Court Judge is accountable for ensuring the operations and procedures of the court comply with the State Administrator of the Courts' Office requirements.
- 2. The Municipal Court Judge is also accountable for the integrity and appropriateness of the judgments made in court.

Working Conditions:

1. The Municipal Court Judge spends the majority of administrative performance in an office setting often under stringent timelines and competing requests.
