The Board will accept additional nominations from District registered voters until November 17, 2025 at 1:00 p.m. All nominees will be evaluated, and a new commissioner will be appointed at a special meeting of the Board of Commissioners on November 17, 2025.

The KCFD #37 Board of Commissioners consists of three (3) members. Commissioners act as the board of directors for the fire district, as well as voting members of the Puget Sound Regional Fire Authority Governance Board. Applicants must be registered voters residing within the fire district. 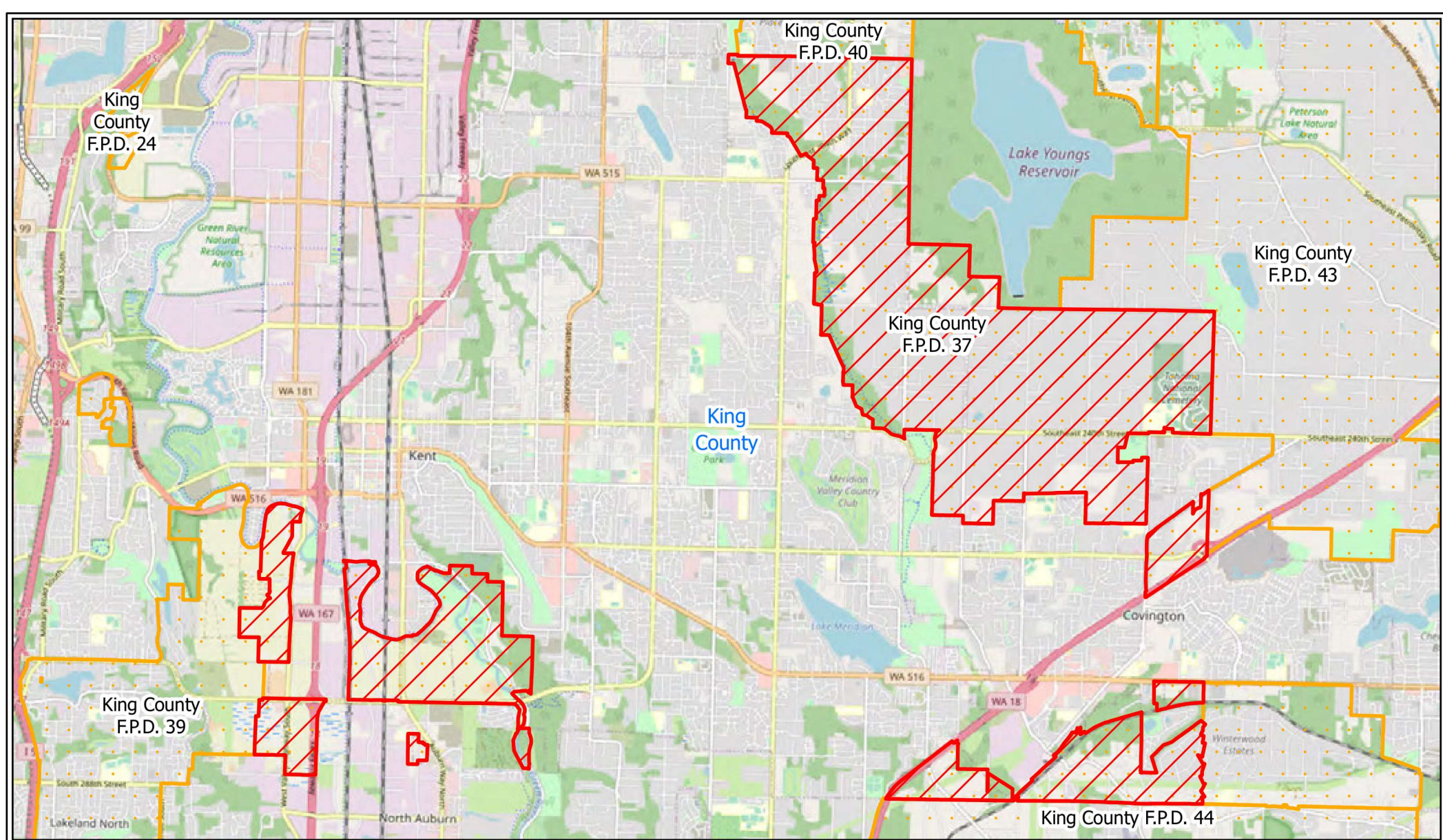

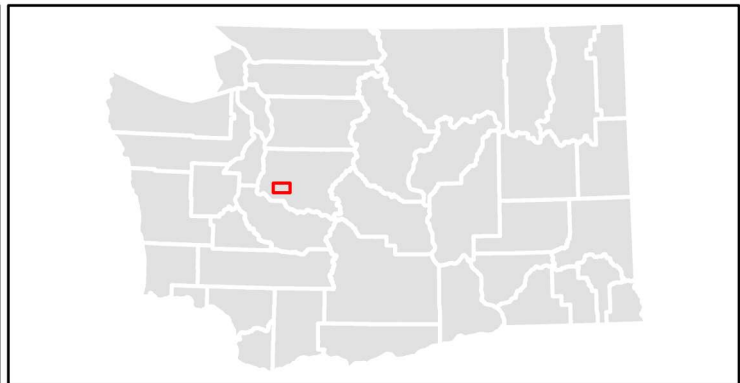
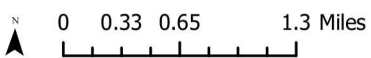
